Ice Scheduler's Report – John:

For the team noted, the Manager declared that he was too busy to put in a report, the coach is attempting to rectify. Kevin advised that he needed to provide closing financials on 2016/2017 Rep/AE year. It was discussed that we could withhold putting the coach's' son and Managers' son on an official roster until this is submitted. All money has been given back to the parents but there is no accounting of where the money is. CDMHA will not allow this manager to manage a team next year.
