#### Ice Scheduler's Report – John:

#### Registrar's Report – Mike:

• Michael will be resigning in the New Year. We will need to have someone shadow Michael starting in the new year as the Registrar position is a big position and will need a handover. Information will be e-mailed to all board members to make a decision if they are interested in the position by 15 Dec 2018.

#### **VP of Rep/AE Report – Jason:**

- Southern Counties Meeting Port Dover, Simcoe and Waterford becoming an A Centre what effects will this have on CDMHA? The membership needs to vote and there is a lot of questions as to where they will play as it is doubtful that they will go into the Niagara loop based on distance:
- The SC plaques will need to be returned for the upcoming play offs.

- Teams had into 15 Nov to be reclassified but none of teams put in to do that:
- SC is considering doing away with the Coach passes for next year and just going with a sign in sheet but this might be an issue for Caledonia due to the lower level not being manned and people already bypassing the payment table; admission is a SC and LL rule;
- Game sheets are not being filled out properly and there has been a coach who has accumulated 7 suspensions for this – tell the coaches to ensure the forms are being filled out

#### **VP of Local League Report – Shawn:**

- Local League Meeting discussion around participants not paying the gate fees and rudeness; it was discussed that something should be posted on our website and other centres will do the same explaining that it is the rules; once the posting goes up at the other centres, we will post something up on our website; currently Glanbrook does not charge as they are in the Greater City of Hamilton but the other centres still want to charge a fee as per the SC and LL rules; Hagersville and Glanbrook seem to be the biggest culprits for not paying the fees and if Hagersville truly needs the fees, they will need to push this to their parents; Glanbrook will need to start following the rules as they are laid out Shawn will bring this up at the next LL meeting.
- Shawn will also speak to Randy Barber about following up with these centres;
- As for the gate fees, there are a number of teams from both Rep/AE and LL that refuse to pay
  the gate fees and in our arena having the downstairs is a hindrance as often spectators will go
  downstairs and sneak into the arena; convenors can try to help if they can and if other board
  members are here they can also attempt to assist;

#### Tyke Convenor/Coordinator Report – Candace/Brent:

- There have been some struggles with the half ice boards due to the benches not being accessible, we might have to move to the Almas side.
- We will get Santa a \$100 gift card for the Santa skate;
- There are still more kids signing up but we are pretty much full now;
- All teams for Tyke need a travel permit for every game and it has been clarified that it is the rules but it seems ridiculous and there is no explanation;
- They will be working on making sure that there is someone at the arena for every game for this level and they are working on the qualifications for all the coaches in every level; we will need to make sure we have the correct coaches on the rosters and that all police checks are valid;

#### **Development Convenor Report – Jeff:**

- We are down for development in the second block and we would like to open it up to the River Cats. It costs us approx.. \$11 per kid for this and we are charging \$10 so CDMHA is covering the cost of the players that are registered with CDMHA. We will charge the River Cats \$20.
- There was good response for IP, Tyke and Novice for first and second block, not for Atom and PeeWee but good for Rep/AE; would we consider opening the second block to Bantam LL and we will post something for this;

- Lisa will look at sponsorship for the half ice boards that we currently own and since the boards only fit on the Almas Side we will not purchase another set of these boards since they will only really work on one side
- Some of the teams will need new socks as these ones are somewhat falling apart but we like this style of sock and would like to stay with one set;
- The new tender will be put out in the new year and there will be hard deadlines put into this new tender; Lisa will look into some of the suppliers to look at the sublimated jersey style;
- We will consider asking for the size of the player when they register and then finalize once the team is picked;

- Would we consider holding Midget Tryouts in the Spring? Not picking their teams as this is against the rules but assisting with Jersey orders and other requirements before the fall; we could offer 4 hours before the fall and then the final two hours in September once the other tryouts are complete;

  needs keys for the office Jamie provided a key for Ian Garson, Ryan Eagles and Geoff
