VP of Rep/AE Report -:

- We are still trying to source the VP of Rep/AE at this time
- Rep tryouts are completed, there has been much concern between the overlap of our tryouts and the A centre tryouts – this has caused some issues and we have done our best to not

overlap timings; CDMHA is happy to see our kids go to higher level centres to try out; it is in our best interest to ensure these kids get on the correct teams;

- There is talk about moving the tryouts to the fall or having a plan with the county to get ice time throughout the summer? Could we move the start of the tryouts to mid-May and hold them in the evenings as well.
- Right before the start of tryouts we were made aware that the OMHA has updated their rules in regards to Tyke players playing at the Novice level – OMHA would allow this as long as those players were in the top 6 of the ratings; 4 players showed up and 2 made the team; they will also allow the 2011's to play in LL

VP of Local League Report – Jason:

- Haldimand LL AGM Shawn attended the AGM in the spring, there were no suspensions for carry over. Finals will be 30 Mar 2019 in Hagersville; there is talk of LL going to electronic game sheets – the cost of the system is \$250 and then \$2 per game sheet but we are quite a ways out from doing this at this time due to the cost, other centres do not want to do this
- The coaching levels and qualifications are going to change at some point according to Linda Ralf, Michael will keep us updated on this as the website gets updated
- Last season for Novice full ice as per OMHA rules
- End of the season Evaluations all coaches have handed this in; there was a little struggle as some coaches do not agree with this; there might be an issue with the new kids coming up from Tyke to Novice, could be that we do one weekend of tryouts or that we simply rotate those players who have not been evaluated throughout the teams. The ice time put aside as evaluations can be given to the teams to start practicing early; Traci will take a look at the P&P
- We are still in need of Convenors, we have a Midget, Bantam and Atom convenors and are in need of Novice and PeeWee at this time; we will update the website for coach and convenor requirements; we will not start the season for those divisions that do not have convenors
- The 2011's could be allowed to play in the Novice level according to the new "rules"
- Jason would like to look at the LL jersey colours this year as he doesn't want the orange, teal etc.

Tyke Convenor/Coordinator Report – Candace/Brent:

- The cheque has been dropped off for the 30% for the half ice boards, they will be 4 8 weeks and Brent will follow up with this company to ensure we have them at the beginning of the year
- Discovery is planned to start approx.. 1 month later than the rest as this is 3-4 year olds with their parents, Brent will tell Johnny for ice time
- There were some complaints regarding ice time as they felt the early ice time was too much every weekend so again, they will discuss with Johnny regarding rotating ice time

- Section H Exhibition Games: Current Wording: CDMHA will pay the full cost of ice, referees and timekeepers to a maximum of two home exhibition games per season.

Proposed Change: CDMHA will pay the full cost of ice, referees and timekeepers to a maximum of two home exhibition games per season. All exhibition games must be completed no later than 31 December of the current year.

 <u>Discussion</u>: The reason for this change is that teams have asked in the past to play exhibition games at the completion of the season. This is a lot of work, time and effort and does not allow us to balance our books in time for the end of the season.

Section E – Goalie Development:

Current Wording (includes): Parents are required to pay for the training up front and submit an official receipt from a recognized Goaltender School/Training Program to CDMHA for reimbursement. All receipts must be dated for the current hockey season i.e. September to April. Please check with CDMHA prior to attending any sessions to ensure that the school is considered recognized by CDMHA.

Proposed Wording: Parents are required to pay for the training up front and submit an official receipt from a recognized Goaltender School/Training Program to CDMHA for reimbursement. All receipts must be dated for the current hockey season i.e. September to April. **All receipts must be accompanied by verification that the lessons have been completed**. Please check with CDMHA prior to attending any sessions to ensure that the school is considered recognized by CDMHA.



CONDITIONS OF CONTRACT
