Reports:

Ice Scheduler's Report – John:

- Submitted ice request for September 2019 to County
- Submitted ice request for 2019-2020(October/19 to March/20 to County
- Submitted ice request for Challenge Cup
- CDMHA needs to make a decision on how the Novice division(Rep & Local League) will work this year from an ice perspective practices & games the half ice boards need to be used on the Almas side so that both doors can be used we should be booking any half ice on the Almas side. Full ice for Major Novice will be starting in January 2020. Practices could be full ice with two teams of the same level on any ice pad (the same as we do now) and then half ice games could be booked on the Almas side. Traciann will touch base with the ice scheduler.
- Current preliminary ice allocation for 2019/20 season is 58.75 hours per week versus 59.75 hours per week allocated last year. The 58.75 hours is 8 hours over are allocated allotment based on the County ice allocation policy. If we want to get back the hour lost there is ice available on Saturday or Sunday @ 7:30am. CDMHA does want this hour back and it can be rotated throughout the teams for practices Saturday would be the preferable day.

Registrar's Report – Mike:

- 23 NRP requests this year; 40 x AAA Permission to Skate Requests
- 243 players/goaltenders registered so far this year
- Sometimes parents and/or guardians register their child(s) for the season...Receive an e-mail that their payment went through but the registration doesn't show under C.D.M.H.A.'s hockey Canada database...This happens when the parent either clicks the back button, closes their browser, or browses to another page during the payment process BEFORE being redirected to

the online registration page, even though there is a pop-up that says to wait. The problems this can create are:

- Rep/AE try-out participants are not on the try-out list...Therefore missing important communication from the coach about try-outs...Which can result in missing try-outs altogether...Which can create headaches for Coaches, Convenors and the Executive.
- Local league players are not on the evaluation lists...Resulting in missing important communication and the possibility of missing evaluations.
- Minor Novice and below participants miss important info sent out by our convenors.

Believe me when I say it's not just our association...This happens to all associations frequently enough, but the simple answer is that parents/guardians that register their children want to rush through the process, so as soon as they see the Success message from the payment provider page after they enter their credit card, they either close their browser, or click back a bunch of times... etc. Unless they actually wait to be redirected normally, the preregistration won't get attached to the invoice that gets created. The only current solution is to ensure we educate those registering.

VP of Rep/AE Report – Beth:

- Tryouts are complete there were a few issues that were addressed. There will be an update to the Policy and Procedures regarding evaluations, tryout policies for the coaches and potentially a year end coach survey. Beth is doing some research on these and we will need to decide how we do this whether it's directly to teams, anonymous and contact info if they wish to put it on the survey;

- Shawn and a few players from CDMHA participated in the first ever Jump Start day outside of Canadian Tire on 6 June 2019 it was very successful and they would like to make this an annual thing; Currently we put \$600 towards Jump Start from the 50/50 at the Challenge Cup (the 2018 Challenge Cup). Would we be able to have a budget that we could use to get "incentives" that could potentially be raffled off in support of Jump Start? We would use the 50/50 Jump Start money for this.

Development Convenor Report – Mark:

- Goalie Development the CDMHA development program is that we reimburse our goalie families \$300 who put in a receipt from an accredited facility; if this is to change this will need to be put forward for a vote; could goalie development be built into the IP/Minor Novice levels – could this be a mentorship program/how would we run this?
- Team Development Burlington Eagles website has an example of how this works; Mark has three coaches Chris Weston, Andrew Guidolin and Brian Osborne who is willing to come out and work with the local league teams they would go to LL practices and be booked directly by the coach with them. We would eventually try to move this toward the Rep Teams; this can also work as coach development as well;
- Is Velonosi able to advertise on the CDMHA website his summer development day camp? This is something that we can look at if we can make a deal regarding maybe a price cut for any CDMHA players who sign up for this? Mark will discuss and keep VP of Business and board informed.
- Would like to have a development committee to help take attendance during development sessions and to assist with research/development of enhanced programs.
- There are other Coaching Apps that are out there and as noted below Andrew Guidolin uses an app called "Coach Them" that he is willing to give information to the Association on;
- For development we can start the Rep/AE sessions earlier and end them earlier since they start doing their Playdowns in January which would open the other times for the LL on the same night; Mark is looking at other options;
