Ice Scheduler's Report – John:

- Practice schedule updated on a weekly basis & are updated to March 8
- All LL playoff games for all divisions are currently scheduled
- All Rep/AE Southern Counties playoff games are currently scheduled
- Cancelling ice with the County as required after all games are scheduled & each team received one practice per week as a minimum - allowed by policy after February 15 to return ice with 5 business days notice
- LL Playoff games to be completed by March 12
- Rep/AE Playoff games to be completed by March 15

Registrar's Report – Mike:

VP of Rep/AE Report – Beth:

- Coach Applications will be posted within the next week or so and will be due back by first week
 of April and hope to have it all done by end of April to let everyone know what is going on;
- SC meeting on Wednesday and should be some information on the Simcoe/Waterford amalgamation as well as the proposed amalgamation for Dunnville and Cayuga
- Novice Jamboree is still being organized- thinking that Waterford will be hosting as they are saying that it will be the same weekend as the Final days (28-29 March 2020)
- We are still waiting on the information from the OMHA regarding Novice Rep fees so far we have done an ice evaluation and according to the ice scheduler there was 83 ice times for last

year and 72 for this year (Novice Rep has full ice practices); will this filter into the Atom level for next year? Games were half ice until a certain point in the season; they feel that they are only paying for a title (this is coming from the Novice Rep parents); we will ask about the fees again as there is a concern that there are no playoffs; according to SC, they did not charge for the Novice Rep team but there is a concern that they are paying for playoffs; we cannot compare ourselves to other centres and ice time as some other centres did not field the same amount of rep/ae teams and might not have the same amount of teams overall;

VP of Local League Report – Erin:

- We will also post LL coach applications same time as Rep/AE;
- Major Novice is doing a final days in Cayuga on 29 March 2020 it's a tournament so they will need to pay (\$300)
- Next year they are throwing out doing minor/major teams for the age groups for LL (Hamilton is doing this now due to numbers)
- Are we in danger of being the odd man out? As a BB centre we are currently sustaining but as the other centres amalgamate there may be no other centres for us to join with;
- Mark has been talking to a few other people and they were saying that there was no guarantee that a team would have to practice in Dunnville but there is also no guarantee that a team would not have to play in Dunnville; they haven't officially reached out to this association to determine if this is the way this association may want to go; Mark Annett will be attending the meeting on Wednesday in Cayuga;

Development Convenor Report – Mark:

- See Annex B Results from Goalie Development Survey
- Development is done now, comments from the survey (goalie) were favourable but there were concerns that there needed to be more instructors on the ice, more emphasis on movement; people commented that they would like to see goalie development at the arena in the future; people committed anywhere from 5-10 weeks (if it happens in the future);
- Coach survey for LL has been sent out (7 have been answered as of today) most said that they and the players had a good season, a few said they would not be coaching again next year; there were a number of answers on different types training required and requested; only 30% said they would use practice plans provided by the association; free online practice plans (these can be found on the OMHA website); only feedback received from CDMHA was negative, run a proper draft; access to additional practice items;
- Can we touch base about midway through the season to remind the coaches about the rules and safety etc;
- Still looking at having some sort of coach mentorship can we reach out to coaches to see if they would be interested in this? Would this be a committee? We would need the right people to do this as well;

Equipment Manager's Report – Leanne:

- Coaches seem to be taking the conflict jerseys to other centres and this should not be happening as it is the other centres responsibility to sort conflicts and our responsibility when it is at our centre;

Annex C Jerseys

\$50 per jersey 17.50 per sock

I worked out the numbers as follows

Rep and AE for 9 teams 20 Home for each team x 9 teams = 180 x \$50 = \$9000 20 Away for each team x 9 teams = 180 x \$50 = \$9000 20 pairs of Socks x 9 teams = 180 x 17.50 = \$3150 Total of \$21150

Local League

15 teams (3 Novice, 3 Atom, 3 Peewee, 2 Bantam and 4 Midget) at 20 jerseys for each team = 300 x \$50 = \$15000 300 pairs of socks = 17.50 x 300 = \$5250

Sponsors and Names \$7 each = \$4620

Grand TOTAL of \$46,020 plus tax = \$52002.60
