#### Ice Scheduler's Report – John:

- Submittal of ice request for 2020/21 season & special events (Challenge Cup) has been postponed until the County knows what is going on with COVID-19
- Ice allocation for 2020/21 season will not be completed un til after ice requests are submitted by all user groups
- Ice costs per hour for 2020/21 have increased 2.7% versus 2019/20
- County is looking to change the Facility Booking & Ice Allocation Policy
- Impacts of proposed changes to Policy for CDMHA:
  - a) Number of hours allocated per week is 58 versus 58.75 allocated in 2019/20
- b) Number of non prime hours required would increase by 3 hours per week this might mean that there could be earlier practices on weekends @ 6am or 6:30am or practices on weekdays before school in order for CDMHA to be allocated 58 hours. This will not be finalized until ice allocation is completed with all user groups

#### Registrar's Report – Mike:

- We are down about 200 at this time; spring tryouts may be the difference as well.

#### **VP of Business Report – Lisa:**

- Would we want to use other jerseys for this year in the event that this year is not a regular year? This would save money in the long run potentially – we will wait to see what September and moving forward will look like for the association.
- Sponsorship already has some sponsors who have reached out and would like to sponsor again and are awaiting details at this time and Lisa will follow up once we have the details of starting up; will sponsors be on the jerseys taking into consideration what the year might look like? We could look at advertising sponsorship on the half ice boards or another way to acknowledge these sponsors.

#### Secretary Report - Traciann:

There has been some communication from the OMHA regarding registration but not taking money from the participants until it is determined what the season will look like and that we are to confirm that we have the money we have already collected in trust – not to be spent until it is determined.

- Constitution Updates See Annex B General Housekeeping it is required to do housekeeping every year so as to keep the constitution updated and refreshed. Both motions have passed;
- Jordan Edl has declined a position on the board.

#### **President Report – Brent:**

- Amalgamation of Cayuga and Dunnville Received an email from Jeff Almas of Cayuga who are still pushing forward with their amalgamation; Hagersville VP is interesting in coming back to the table to see what is happening Brent would like to have a few people from the association to be on a committee and please reach out to him if you are interested Brad Vanderburg, Tom Neilson and Mark Annett are interested in being on this committee; Paul Riley would be a back up; as an Association are we still interested in moving forward in getting this information regarding amalgamation;
- Return to Hockey (Annex C) Hockey Canada will let each Province's Guide the opening for us that is OHF Ontario Hockey Federation there is no return to hockey dates at this time OHF is hoping it will be after labour day but as of right now everything is still suspended; it's okay if we have accepted money as long as we are not spending it; opening can happen in stages (our region is not opening in Stage 2 at this time), Rep (travel hockey) and tournaments are all up in the air and it will come down from the public health; certification information has been released that we can do online or that certifications have been extended at this time; there is nothing in place for someone who has not coached before at this time; there was a lot of speculation, no one knows where we are going to be at in September. Hockey Canada has the plan, public health and provincial regulations will dictate what we can do along with our facilities; no one knows what this looks like right now;
- OHF meeting staged approach depending on when we begin the season if we start in September – 4 stages 1 – individual training groups of less than 5; 2 – small group training not full teams 3 - non-traditional training, possibly 3 on 3; 4 - full programming - but it is clear that when we return to hockey, it will not be as it was when we left. We will need to approach things a lot differently then what we left off – it sounds like it will be very small groups of skills training for quite some time and if we are lucky maybe back to regular hockey, maybe travel, maybe tournaments – this will be a big adjustment; remain in contact with our facilities to see what they will allow and what they won't allow us to do – i.e. if Haldimand says 10 at a time on the ice. then we can have 10 people but other municipalities might not have that or we might not have that; we will be in a touch situation of budgeting – we could possibly lose money – there could possibly be less people signing up and our sources of revenue may not be there - people might not come – gate fees will be down, sponsorship may be down and we may not be able to have a tournament that is a big fundraiser for us – we need to look at different ways to save money – everyone; options are cancel development as hockey might be all development or not subsidize it; maybe we do not order our jerseys right away - can we wait on this as the season might not start right away – need to come up with ways to be as efficient with our money as we can be.
- Can we look at using our half ice boards to put more distance between people on the ice;
- Fees we may have to be able to refund fees in the future depending on the start of the season; tournaments may not be allowed to happen due to the cost of these – these need to be affordable but sometimes with hotels, etc they are not – OHF and Hockey Canada really wants hockey to be affordable;
- Money paid to the Registrar and the Scheduler I believe that we are going to need the scheduler more than ever and registration is a huge up taking
- We normally pay for exhibition games and since there may not be any, we could save on this;
- We could cut out team parties for this year to save some money;

Re: Hockey Canada's Return to Hockey

Today, Hockey Canada has released its Return to Hockey Safety Guidelines. In addition, the Hockey Canada Board of Directors have announced that Members may resume sanctioned activities where appropriate, in accordance with government and health authority directives, and Hockey Canada's Return to Hockey safety protocol.

Within the Return to Hockey Safety Guidelines, Hockey Canada has provided information on how to prepare your league/association for a return to hockey, hygiene, return-to-play protocols and the use of facilities. #### HOCKEY CANADA STATEMENT ON RETURN TO HOCKEY IN CANADA

CALGARY, Alta. - The following is a statement on behalf of Hockey Canada from Tom Renney, chief executive officer, and Scott Smith, president and chief operating officer, on the return-to-hockey process in Canada.

"On <u>March 12</u>, the decision was made to cancel all Hockey Canada-sanctioned activities across the country. This was a difficult decision, but one made to maintain the health and safety of all participants and the general public amid growing concerns around the coronavirus (COVID-19) pandemic.

Currently there are no Hockey Canada-sanctioned activities being conducted, and we are working with our Members on their return-to-hockey plans. After ongoing discussions with the board of directors, our chief medical officer, the 13 Members and public health authorities across the country, it has been determined that the best approach for a return to hockey in Canada is to allow each Member the opportunity to work with authorities in their respective regions to determine when it is safe to return to the ice in areas that fall under their jurisdiction. We expect the timing of each Member's return to hockey will be different, but will be based on the advice of their government and public health authority.

It is imperative to note that we are not ready to return to the game across the country. As we have seen in respect to flattening the curve, the impact of the pandemic varies from region to region. Permitting our Members the opportunity to decide on an appropriate return-to-hockey timeline will allow them to work directly with public health authorities to determine when it is safe to return while also implementing specific safety measures and rules within their associations and leagues.

Hockey Canada knows the game will look quite different, and the return will happen at different speeds and at different times across the country. Be assured, we continue to work on our multi-faceted return-to-hockey plan that includes health and safety regulations, communications and seasonal structure. As with so many people across the country, we look forward to returning to the game when it is safe to do so, and we will support our 13 Members as we continue to work towards getting back on the ice."
