Ice Scheduler's Report – John:

- Total regular ice cancelled to January 30 is 211 hours with a cost of \$27,700
- Rep/AE season resumed January 31 with all games needing to be completed by March
 13
- U9 LL full ice games scheduled 6 games per team
- U11/U13/U15/U18 LL regular season completion date extended to February 20
- There has been some discussion on extending the Haldimand LL season to April 16 no decision to date & no decision on playoff format – ice request is due on Friday to allocate ice
- LL Finals will be the Saturday of Easter weekend if the season gets extended there
 will be 5 weeks to get the playoffs in if they do not extend the season for LL there will
 only be two weeks
- Information provided is that Rep/AE playoffs and venues have already been booked and scheduled which is why there is little appetite to extend the season
- There are also arenas that cannot extend the season due to the facility
- Will we extend the season for Discovery/IP1/IP2 (3 for Discovery and 6 for IP1/IP2) we cannot know until we know if the ice itself will be extended and/or moved.
- County is looking to update the ice reallocation and booking on 15 Feb that the Ice Scheduler will attend on behalf of minor hockey
- The Challenge Cup is a grandfathered tournament to CDMHA. CDMHA will continue to keep this as a LL tournament.

Registrar's Report – Mike:

- There is still one person who has not paid in full this player is not on the ice until this is paid



Calendar/Availability

For the traditional green screen option, we can provide up to four photographers that can photograph 4 teams per hour, at 15 minutes per team. For our "Pro" option, 20 mins per team is required. Minimum space is 15' x 15' per photographer. Location of photoshoot is decided by the league, usually taking place at the arena or community centre gym. Photos can be scheduled to be completed in one full day agreed upon beforehand or can be taken over several nights in smaller time frames. Photo dates will be booked on a first come first serve basis. No staffing by the league is required. However, having a league rep who is familiar with the teams is helpful for a smooth day!
