#### Annex C Development

#### Goalie Development Proposal

To provide goalie development at the arena in Caledonia, the proposed dates are Oct 4,11,18,25, Nov 1,8,15,22,29 and Dec 6 at 5:30 pm for all dates.

I received tenders back from 2 goalie development providers On Ice Performance and Grainger's their pricing is below.

ON ICE - Is an operated by Derek Bujan who lives in Caledonia. Their main place of business is in Hamilton, On ice employs several people from Hamilton to help deliver his goalie program. ON ice has been in business for a long time and is a trusted developer to several minor hockey associations and individual minor /jr goalies for their goalie development.

Pricing: Standard Clinic - \$399.99 + tax + ice costs If we book all 10 sessions 365.99 + tax + ice cost

#### \$595/hr - x 10 sessions \$5960

Graingers - Is operated by Nick Grainger who is from Hamilton, grainers main place of business is also in Hamilton. Grainger's employs several trainers to help deliver his goalie program, two of which are from Haldimand Keegan Jackson (Corvairs) and Tanner Richardson.

Graingers has been in business for a long time and is a trusted goalie development provider to several minor hockey associations, OHL Hamilton Bulldogs hockey team as well as the head goalie development coach for the Toronto Six women's pro team.

#### **Pricing:**

4-8 \$275 tax included + ice cost =  $\$425 \times 10 = \$4250$  \$531 goalie - Running 6 sessions – would mean that we would not need to charge anyone  $\$425 \times 6 = \$2550$  total Offered for U13 and below \*\*Other levels could come if we did not have 8 goalies but the same rules would apply – this is their goalie development as it is being offered by the association. Proposal from Mark Annett, seconded by Roger Long. Motion passed.

If there are more sessions run then the cost of this would be borne by the participant.

8-12 \$325 tax included + ice cost

If approved, I would like to try and run a shooting development on the other half of the ice at same time. This would be provided by myself and up to 2 other volunteers. My only issue would be not having enough nets to provide development for goalies and players at same time, there are a couple of groups that own their own nets so I may be able to approach them for some help.

#### Player Development

Sandy Velenosi is in the last year in his 3 year agreement the cost for this is \$175 per hr. I have requested that he provide us with monthly billing to help reduce any discrepancies. I am suggesting that we run a 16 week program starting Oct 2 that will cost parents \$13 per session or \$210. I have had several inquiries so I do not think it will be a problem filling this program. If there is tax in the cost of this then we would have to charge \$15/hr.
