Meeting Called to Order @ -

- 1. Approval of December minutes: not enough board members to votes 5 min
- 2. Approval of January agenda: not enough board members to vote.
- 3. Ice Schedulers Report: John 10min (15m)
 - Practice Schedule all teams have been scheduled for one practice the week of January 13-19. More practices will be added for this week & balance of season once U11, U13 & U18 playoff schedules are completed
 - U11, U13 & U15 teams have been scheduled for a minimum of four full ice practices to January12
 - Regular Season Ends January 12 for U11, U13 & U18
 - Games for A/B Playoff Split to start January 15 tentatively for U11, U13 & U18
 - All playoff games for U11, U13 & U18 and U15 regular season to be completed by March 6
 - Semi Finals for U11, U13, U15 & U18 to be played between March 18 to 26
 - Hagersville March 29th Finals
- 4. Registrar's Report: Michael 5 min (20m)
 - All rosters are approved, except for U9 Select,
 - All registration fees are paid up.
 - Jan 15th for AP's to be added to rosters.
 - To use AP's when players are NOT missing will need to be on a case by case basis.

- Jan 2nd an email was sent out that 6 (Phill Sholtz, Bo Bottenfield, Chad bridges, Neil Holt, Adam Raven, Wes Pauls) coaches are having VSC expiring and will be pulled from the roster as of Jan 8th if not submitted.
- U13 Select owes \$13 for a travel permit.

5. VP of Local League Report: Traciann – 5 min (25m)

- Adam Raven is looking for board approval to allow the use of AP's for all his upcoming games. He currently has a roster of 11 and would like to bring up an AP to put his roster to 12. HLL rules allow U9 to AP to a maximum of 12 but the CDMHA rules only allow for AP's in the event of absence of other players unless approved by the board. I am making a motion to allow the U11 teams the use of AP's to bring their rosters to 12 if need be. I will need a second and a vote.
- From HLL Meeting: U7 & U8 teams will not need travel permits for their exhibition games played at other centers as long as they are scheduled by the center and recorded on the website. If teams reach out to other centers to set up their own exhibition games, they will need travel permits.
- please ensure that Participation game sheets are being filled out correctly. Our center is doing a good job but other centers are not. They need the players' full name and number and signatures.
- U9 team codes will be out to me this week and I will forward off to the coaches so they can set up their rosters electronically for gamesheet in preparation for the full ice part of the season.
- Super Sunday. I would like to host the U9 Super Sunday on 30 March 2025. This
 would entail a "playoff" day for all U9 teams from all centres. Cayuga hosted last
 year. Each team would get two games that day and a medal at the end of their last
 game. Each centre would assist with costs for ice, referees and medals. I checked
 and the ice is available. I would need board approval to go back to the other
 centres. Paula is on board to assist me with this for that day.
- At the request of the Haldimand LL, there has been a form set up on the Haldimand LL website to report suspensions either served at tournaments or received at tournaments. The coach can either communicate to VP LL or complete it themselves. (John will speak to this as he created the form).
- There will be an update to the VSC next season. Details to follow
- Referees are being Strick on the penalty 11.4.
- An email was sent out today about all LL centers, regarding U6 and 7 need to be cross ice games, not half ice games. Associations could be sanctioned if they are caught.
- Trying to black out dates for U18 around exam dates.

- U6 coach was requesting ice time, can be requested through John.
- Review with Traciann if U6 teams are able to play cross ice games.
