Meeting Called to Order @ - 6:32

- 1. Motion to accept September Minutes by Ashley and seconded by Betty
- 2. Motion to approve October agenda by Kelli, seconded by Corry.
- 3. Ice Schedulers Report: John 10min (15m)
 - Main Ice & Tournaments Permits signed by deadline
 - U5 will start October 26 ends March 1st.
 - U6 has been posted ends March 2nd
 - U7 time change has been posted.
 - Practice Schedule updated to Nov 3
 - Kev Season Dates:

A.U9 Half Ice Games (8 Games) - to be played between November 17/24 to January 12/25 then transition to full ice games starting January 15/25

- 9. Equipment Manager Report: Corry 5 min (50m)
 - Misunderstanding of how many jerseys were ordered. 665 Jerseys were ordered and there was only suppose to be 266 ordered.
 - Traciann sent a list to Corry in June,
 - ILA was sent list that Corry provided.
 - Aug invoice was issued
 - Invoices were sent to Corry, Mark and Erin. Erin paid 50% of invoice.
 - Received in office 247 with 19 to come.
 - Sept 17th was aware of this error, invoice should have been for \$19,152.
 - We are able to use jerseys for future years.
 - ILA is working with us on miscommunication.
 - We will most likely have to store them here vacuumed sealed.
 - Discussion to initiate a process that any payments over \$1000.00 has approval from the person requesting the payment and the president.
